

## Lithuania Innovation Policy Summit

Lithuanian Innovation Center organised on May 17 in Vilnius an event open to triple helix innovation actors with the aim to share experiences on the issue: "Strategies to reinforce private investments and collaboration". The InnoSummit offered an ideal platform for key stakeholders from public and private sectors to exchange their views on ways to foster cooperation between business and science, strategies to stimulate private investment into R&D and innovation. More than 150 participants from Lithuania and other EU member states, including politicians, representatives of education sector, business and social partners, took part in the event. ## Interregional Meeting in Cambridge

In the framework of the HIGHER project, Greater Cambridge Greater Peterborough Enterprise Partnership (GCGP) organized on 30 March 2017 an Interregional Meeting at the Future Business Centre, Cambridge. The meeting examined different approaches to Smart Specialisation in the context of the policy instruments chosen by the nine HIGHER project partners. This was done through an initial scene setting presentation linked to the benchmarking exercise that formed part of the second semester; a series of presentations highlighting national, regional and local approaches in the UK and Sweden; a series of best practice presentations related to the UK policy instrument; and, finally, a series of presentations from other HIGHER partners demonstrating best practice approaches to Smart Specialisation and highlighting the Entrepreneurial Discovery Process, governance and transnational collaboration and value chains.
