Before the action plan

- Digitising for more than 20 years
- Little cooperation
- Duplication
- Competing for funding
- Larger vision was needed



How?

- Initiated by the Digital Heritage Council
- Ministry of Culture
- Ministry of Education and Research
- Ministry of Economic Affairs and Communications
- Working groups of specialists

Why?

- Digitising ensures preservation and accessibility
- Estonian Information Society Development Plan 2020



The main objective of the action plan is the resource-efficient digitisation of a critical mass of the cultural heritage, as well preserving it and making it publicly available.

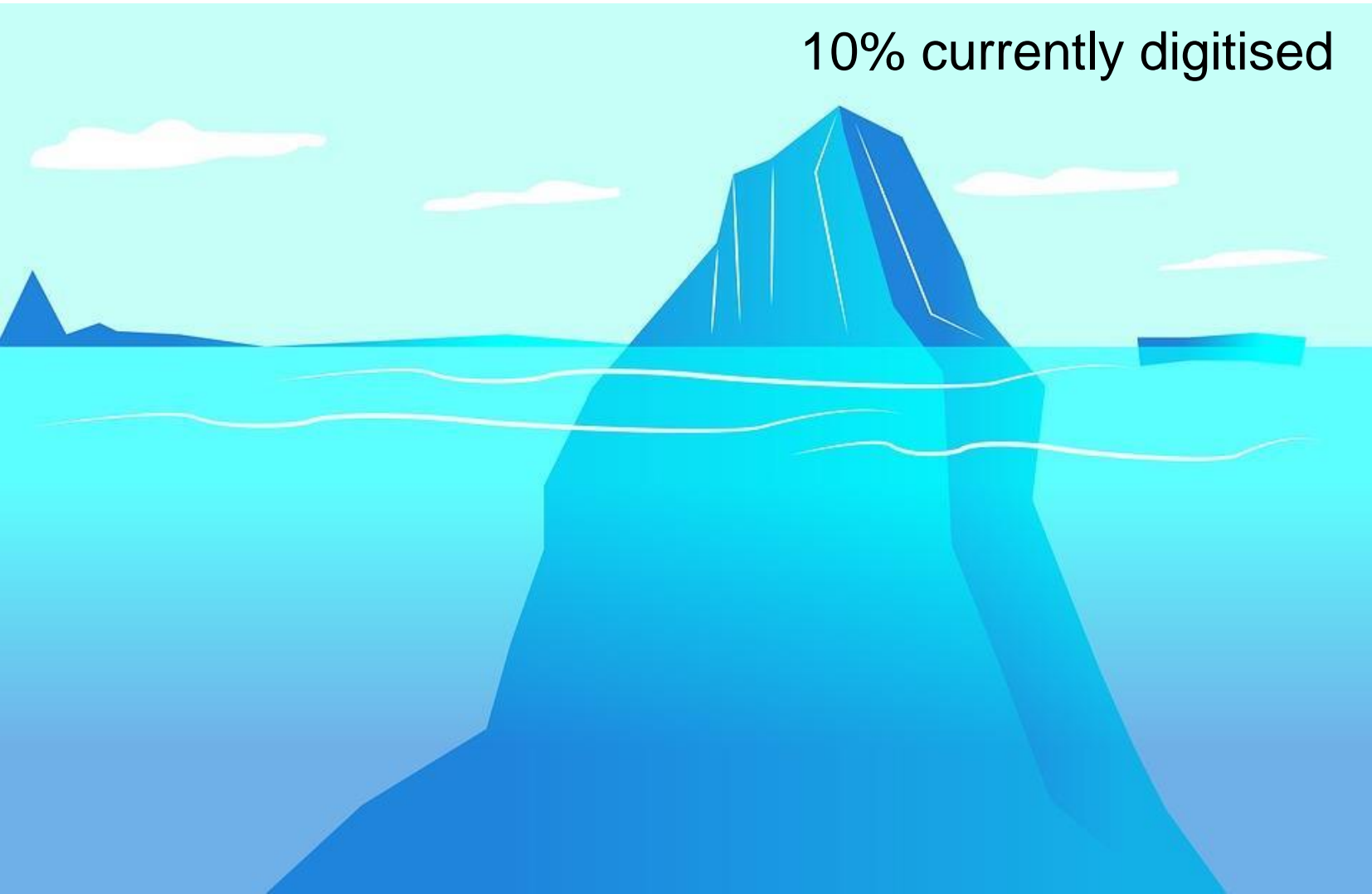
Sub-objectives:

- 1/3 of cultural heritage available digitally
- Consolidated architecture and service for archiving and long-term storage
- 1.2 million objects available as open data
- Increased knowledge of digitised cultural heritage
- Active reuse in the public and private sector
- Public awareness and increased satisfaction with online services

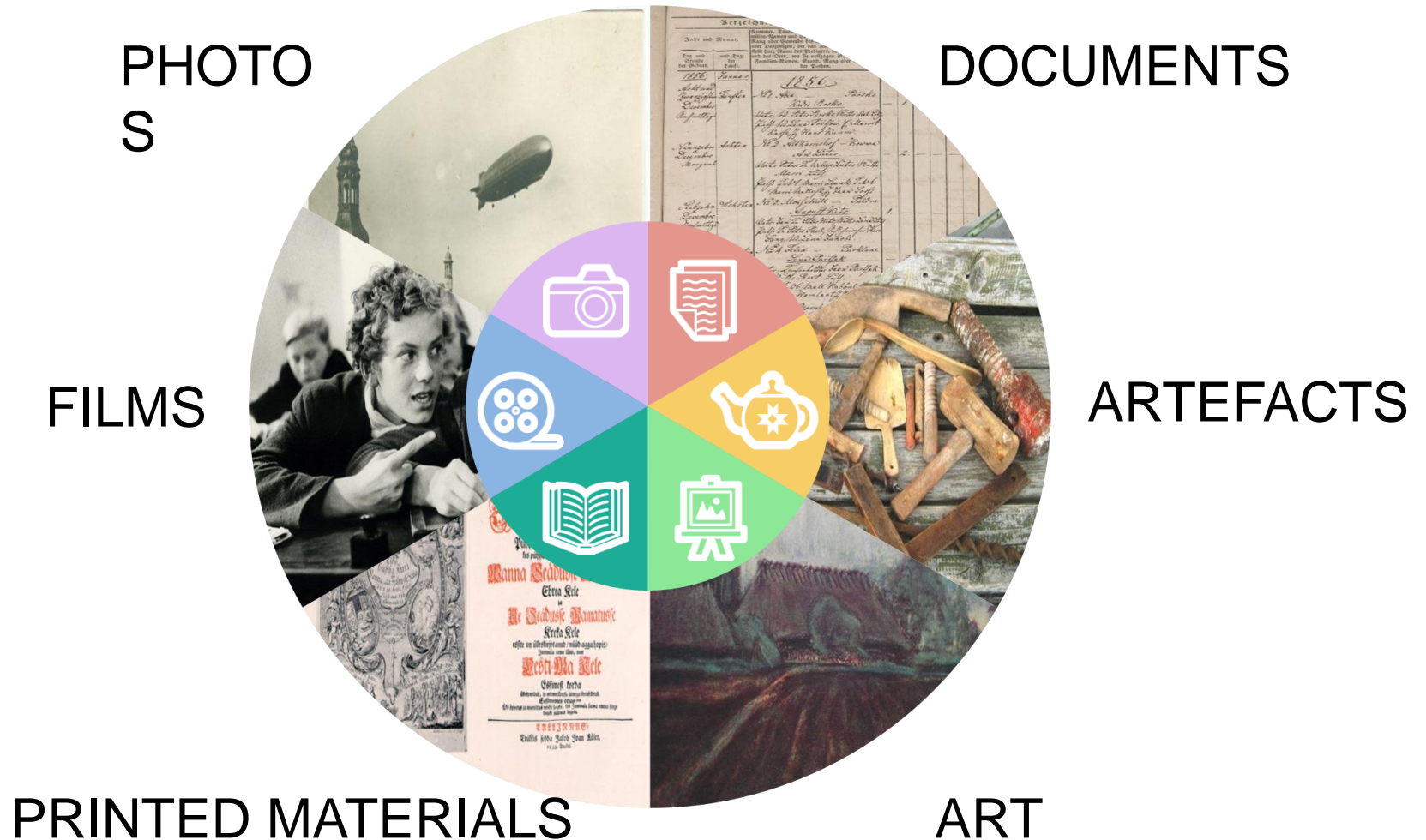
Budget

- Total cost €9.02 million in 5.5 years
 - €0.83 million national budget
 - €8.19 million EU SF

Over 900 million significant objects that
deserve digitisation

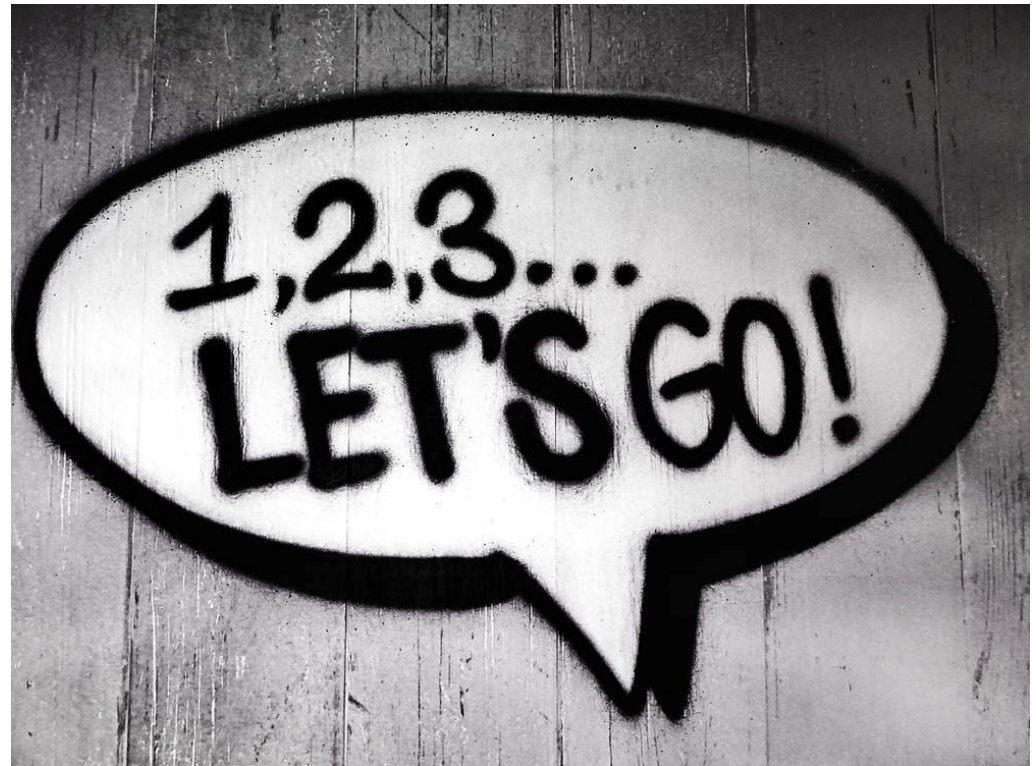

- Working group meetings

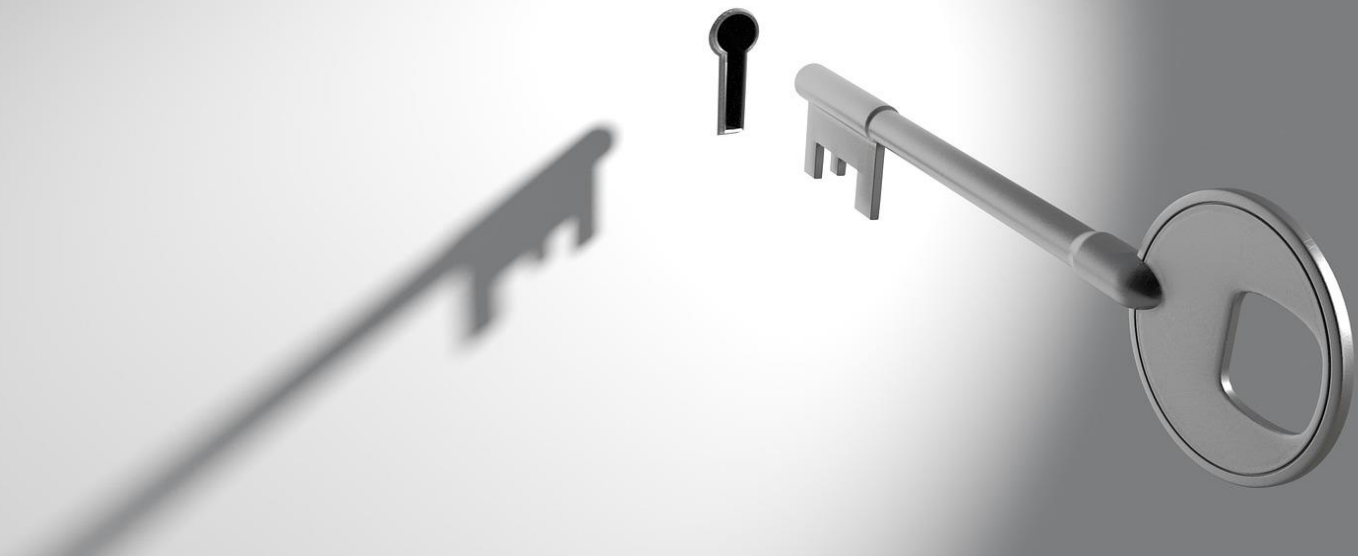


DIGITISING

- Including the pre- and post-activities
- 12 projects altogether
- 7 already started:
 - digitising documents, printed materials, artefacts, films and photos
 - documents and artefacts applying for financing for second project, others will soon follow

Development

- Making digitised heritage available
- Estonian Museum Information System
- Digital Cultural Heritage Access Information System and analysis

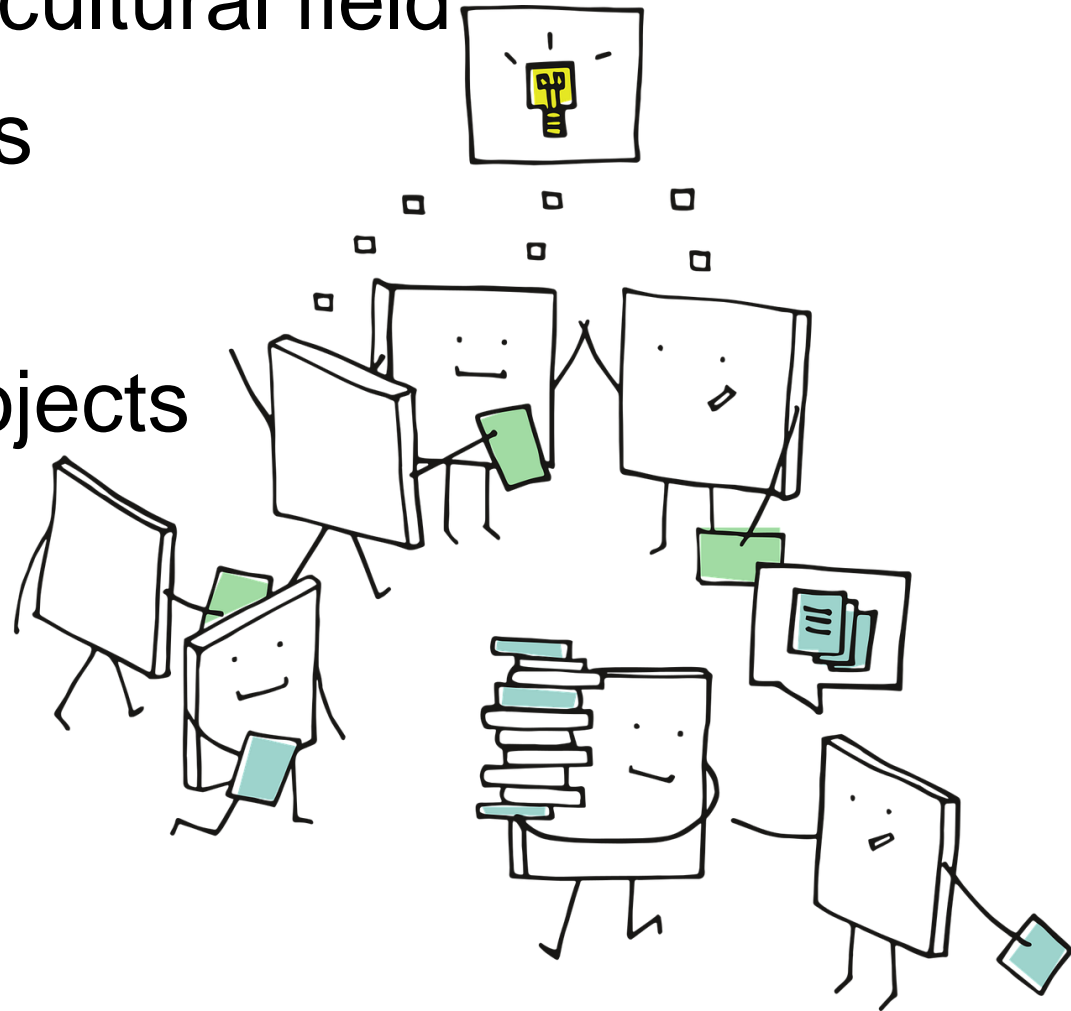


Infrastructure

- Acquisition of digital archive software for national publication
- Mirroring the Estonian Public Broadcasting's and Estonian National Archives' tape drives in another geographical location

Notification

- Training for the cultural field
- Information days
- Seminars
- Cooperation projects



Results (combined with previously digitised materials):

- **3%** documents
- **32%** artefacts
- **60%** films
- **60%** photos
- **28%** printed materials



Beneficiaries

- All memory institutions and their users
- Developers of educational, cultural online services
- Estonian open data community
- Computer-literate population
- Media companies
- Interest groups abroad



How can new content be used?

- Solutions supporting school curricula and higher education and research
- Research cooperation
- Services for the creative economy
- The opportunity to use periodicals at the article level
- Services that support tourism
- Media projects
- E-services of state registers

Conclusion and next steps

- Maturity level of digitisation has increased
- Inter-institutional cooperation has increased
- Cooperation network remains with coordination centres
- New action plan for 2024-2030
