Lodzkie	2 kind of criteria: 1 is officially approved in ROP, water and wast-water management; second criteria for the textile and fashion industry most important RIS3 sector for Lodzkie criteria have been identified and proposed for approval (4 group of criteria)
Fryslàn	Cooperating with neighbouring regions for the next programming period in which CE is central, new calls no launched yet but priorities are set
Hamburg	In contact with responsible body, reforming under-implementation, assessment criteria already presented and will be taken into consideration,
North East Romania	Still in programming phase, monitoring closely the development for then proposing the criteria when applicant guideline 2 nd stakeholder meeting to be involved in the selection of criteria; Within the 8 rop of Romania NE is the only one with CE dedicated call: front-runner in this at national level
Centro	Already used in the call dedicated Proof of concept call, the results came in Feb 2022 so will be reported in semester 6; new ROP: because of climate mitigation, using CE assessment criteria in broader calls, as an horizontal objective contributing to climate mitigation
Crete	Focus sectors: tourism, agri-food; assessment criteria have been shared with
