### Geographical coverage



South Central Region of Bulgaria

NUTS2 region, 5 Provinces: Pazardzhik, Plovdiv, Smolyan, Kardzhali, and Haskovo

58 municipalities

Total area is 22 365,1 km<sup>2</sup>, accounting for 20.07% of the country's territory.

Population: 1 413 840 citizens

Population density is 63.2 people / km<sup>2</sup>



### Policy instruments addressed

The Regional Development Plan of the South Central Region with the support of the Ministry of Regional Development and Public Works

Local strategies for sustainable energy and environment protection, which public administrations have to develop as according to the Bulgarian legislation (Energy Efficiency Act and Energy from Renewable Sources Act)

- This activity is ongoing. EHD is fully operational.

- Experts of CSEG are organizing bilateral meetings with stakeholders from the Region

- Topics of discussion: energy planning, policy development in the area of climate change issues and protection of environment, and how local policy by-laws can be developed or where existing - improved.

- CSEG is currently evaluating the possibility to continue this activity beyond the project end; EHD could bring expertise and added value to the local environmental initiatives in the following years.



### Measures in the GPP Plan 3. GPP Forum

Activities:

- Dissemination event with high impact on a specific topic like GPP.
- Try to organize such event each year.




#### 3. GPP Forum

### Difficulties

• What has worked out bad in the implementation of your Action Plan? At the beginning – practically impossible to organize a physical event.

• Which are the main obstacles encountered in the process and how did you overcome them? (e.g., lack of commitment of the stakeholders...)

One large public event = several small bilateral meetings

- Which are the main learnings from this experience?
- There are alternatives to large public events: could be online meetings, exchange of e-mails, bilateral meetings, etc.
- Establish synergies with other similar initiatives/projects could be the key to success.



### Successes and Lessons learnt

 What has worked out particularly well so far in the implementation of your Action Plan?

Some research desk-based activities have been done at the very beginning of the implementation of our AP – not affected by the pandemic situation at all!

Bilateral meetings with stakeholders.

Small workshop/training session with just 6-7 stakeholders.

Combining AP activities with another initiatives or project events – synergies with other initiatives/projects.

Which are the factors that contributed the most to such success?
Good planning of activities since the very beginning of the AP implementation.
