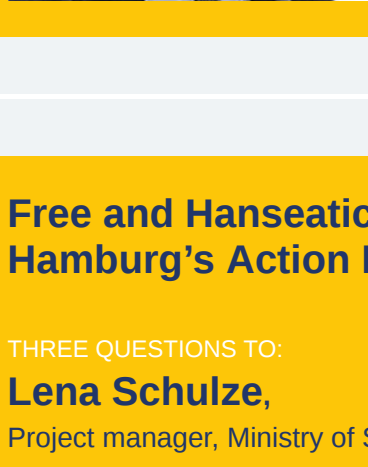


## The Regional Action Plans
