<p>Historical background</p>	<p>The Community Region of Teruel is rich in vestiges of the civil war that was lived with such intensity and harshness in these lands that it became the scene of multiple war episodes between 1936 and 1939, whose traces of destruction and suffering are difficult to find. in other parts of the national territory.</p>
<p>Current status</p>	 <p>The rugged orography of the area is strewn with innumerable trenches and shelters, machine gun nests, pillboxes and all kinds of defensive structures that time and oblivion have softened until they are almost invisible to the inexperienced eye, merging them with the natural environment .</p> <p>The Region has valued this wealth of heritage with the ATRINCHERATE brand.</p>

Several enclaves have been identified and their visit has been facilitated, through dissemination on the web, and with catalogs. They have been signposted to access them, and nearby parking areas have been prepared. Recovery and consolidation of various war structures, trying to stop and reverse the processes of degradation to which they have been subjected for seven decades, derived from erosion, reuse of materials and, on occasions, systematic processes of colmatation and destruction (cleaning, consolidation and detection and removal of explosives if any).

Public consultations on the actions, if any	There has been no public consultation, but it has been included in the Strategic Plan for Regional Development for the period 2022-2026 that we are carrying out at the moment through a broad participatory process.
Public opinion	Given that these vestiges are located in strategic places with good visibility to defend the territory, the regional strategy revolves around the idea that they are splendid viewpoints. For this reason, both the description of the vestige and the landscape are offered. Any ideological bias is eliminated and this avoids hurting sensitivities since there were many local people who died in the contest.
Existing problems related to the preservation of the Fortress and the development of the area	. You have to be careful with the message that is transmitted. You have to select well the resources that are valued (location, accessibility, interest...) You have to get funding for cleaning, restoration and musealization.
Solved problems related to the preservation of the Fortress and the development of the area.	Message to transmit: description of what happened in each vestige with historical accuracy and impartiality. Some requirements have been defined to be fulfilled by the vestiges that want to be part of ATRINCHERATE and have been applied for their selection. Funding has been obtained from the Government of Spain and the Government of Aragon for the cleaning and restoration.
