
Summary of the event



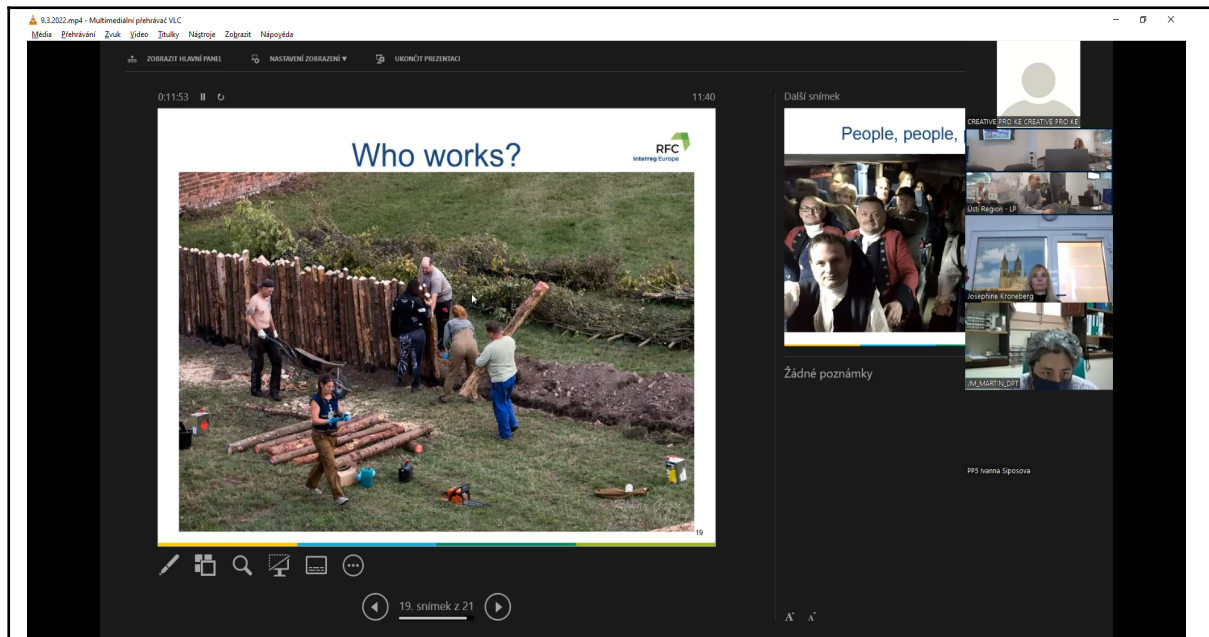
