REPORT OF THE DISCUSSION

Brief report of the discussion

The discussion was the final part of the agenda of the meeting entitled "LCAction for the Region - The Circular Dimension of Enterprises Development". It involved representatives from all sides present at the meeting - the scientific, business and public sectors. Opinions were not divided, however, the participants jointly came to the conclusion that:

- the emerging challenges in the field of sustainable economy and energy efficiency require more careful analysis of innovative and effective measures to minimize the impact of harmful factors on the environment and climate;
- all of the above mentioned sectors should work together to sustain development and reduce the negative human impact on the environment by creating and participating in joint proenvironmental projects, research and innovation;
- to change present situation and problems connected to climate changes and increase efficiency of resources more learning and promoting circular economy, life cycle approach activities and usage of green public procurement are needed.

CONCLUSIONS

- There is need for education, business and public sectors to cooperate in order to promote circular economy and sustainable development objectives by creating and participating in joint environmental projects. All of them should work towards these goals at national, but also international level.
- The use of green procurements by public institution is big step for making municipalities more environmentally aware. But there is constant need to educate people to understand why these actions are necessary.
- Enterprises are still not convinced about idea of using green solutions in their everyday work. In Poland numbers of enterprises that are trying to introduce new, planet-friendly solutions are growing. In the Lodzkie Region there is not so many of them, who focus only on sustainable production. In private sector if some companies operating in this field, they are in particular SMEs who have set up their businesses precisely to introduce green solutions and products.
- During the pandemic, the way of working changed and everyone had different priorities, but still in some areas green solutions have been applied, especially in the area of public procurements.
- Regional action plans and funding opportunities for environmental projects provide an excellent opportunity to realise problems that the world currently face.
