According to the agenda, the SWO RDA implementation team presented the objectives, activities, expected outcomes and implementation stage of the project, with focus on the regional policy instrument, in this case represented by the Priority Investment 2.1A within the Regional Operational Programme 2014-2020.

Three good practices identified and implemented by the Lead Partner, University of Gävle, in the field of energy efficiency of SMEs were introduced to the stakeholders, respectively: Software for industrial energy auditing; Energy efficiency networks ENERGIG; and Database for energy efficiency measures. All three tools were part of a pilot program initiated by the University of Gävle, targeting the improvement of energy efficiency in industrial SMEs from the Gävleborg region.

During the interactive part of the meeting, business environment and regional public authority representatives debated the needs and proposal of improvement measures for the regional policy instrument that addresses the SMEs in SWO Region. In the debating session the stakeholders were showing a lot of interest in the Swedish good practices, and they've asked questions about how the program was implemented, expected results and from which type of financing sources it was funded.

After an intensive Q&A session, regional stakeholders expressed their interest to be directly involved in the project activities. Further activities in the project will focus on the ways that the partners can improve their regional policy instruments. The interregional exchange of experience and know-how will help partners to offer better support for adopting measures and will allow to capitalize the potential of the energy efficiency programmes that apply to industrial SMEs.

Since we are in the Action Plan development phase, the discussions focused mainly on this topic. Thus, taking into consideration our policy instrument and the fact that we are at the ending of the 2014-2020 financial programming period, we discussed the possibility to influence our policy instrument by good governance (as also written in the application form). All the participant stakeholders discussed that a good way to do this would be to try to influence the policy instrument by taking the following possible actions:

1) By improving the monitoring procedure in order to try to quantify the impact at SME level in energy efficiency gain;



2) To build a public, free of charge, data base (at regional level) by describing the sectors of activities, the taken measures and the results obtained after implementing them; this tool could be also used by other SMEs that haven't adopted any type of measures in order to obtain energy efficiency.

Expert opinion

SMEs are among the target groups for resource and energy efficiency upgrades that are most difficult to mobilise, and dedicated programmes to support and motivate SME owners to take action are needed.

External advisory services such as energy and material use assessments bring the required expertise into the SMEs that typically do not have their own dedicated skilled energy or resource manager intro muros. The PIUS check does this.

Once the savings potential has been identified, it is further highly recommended to offer followup financing support for the implementation of these savings measures. To this end, a mix of grant and loan is best practice with SMEs. The PIUS Invest scheme offers this, and links nicely the level of grant to the savings expected by the investment, expressed in CO2 equivalent.

Overall, the PIUS check and invest scheme is a very good package to support and motivate SMEs to invest in resource efficiency.

Financed with ERDF, this is a handy tool of high interest to any MA who wishes to support their SME based in greening their business.

Energig Sweden

Expert opinion

Simon Hunkin

SMEs often struggle to implement energy efficiency investments, lacking both financial resources and the knowledge required to make investments into new technologies and processes. This practice for training and assisting SMEs is a strong example of business support, grouping companies into networks to provide support, with meetings a few times a year. The resulting average saving of 16% is impressive, and, as the practice notes is significantly higher than similar interventions. The practice could be transferred with the right skill and personnel, as well as with robust outreach activities. Gaining the trust of SME owners and communication the benefits of taking part will be key challenges.

Energy-efficiency through law enforcement

Expert opinion

Simon Hunkin

Energy efficiency can be encouraged with soft measures, or made mandatory and enforceable. However, the main challenge from this is the enforcement itself. The ensure action, municipalities can provide information and assistance to companies to help them take required actions, and also police enforcement. This practice combines the two approaches, providing information to all affected SMEs, requiring a plan which can be monitored, and then following up to ensure that actions have been implemented. The practice could be transferable, dependent on an enabling legal framework, sufficient financial resources and access to both legal and energy expertise. The high impact – 700 SMEs approached – could provide some additional incentive for regions looking to replicate.



Energy Efficiency Grants in La Rioja



Expert opinion

Simon Hunkir

SMEs often lack the knowhow, time, or resources to improve their energy performance, but there are significant improvements to be made and SME transition will be essential for meeting climate targets. Like several other schemes, this practice demonstrates two types of support: 100% funding for energy audits and advice, and a reduced rate of support for investments in the actual improvements, to leverage private investment. The two types of support are essential: the energy audit itself should be able to demonstrate to an SME the benefits of intervention, while the investment grant enables implementation. Providing the two separately enables SMEs to skip the audit step if they are already sure of the interventions they wish to make. The leverage rate of this practice demonstrates a good level of success.

Smart Businesses Groningen (Groningen Werkt Slim)

Expert opinion

Simon Hunkin

SMEs face several barriers in improving their energy performance, including lack of resources and information, and risk aversion. Many regions across Europe are now developing support schemes to provide advice to SMEs that can demonstrate the benefits of energy improvement and also help to de-risk investments. This practice is interesting for its online calculator and helpdesk – this may not be as accurate as a full energy audit, but enables the platform to reach many more SMEs for a small budget. Additionally, the focus on aspects beyond energy (renewables and efficiency) such as circularity and mobility is interesting. A key challenge for any region is communicating with SMEs, and the involvement of the local business association can play an active role in this.
