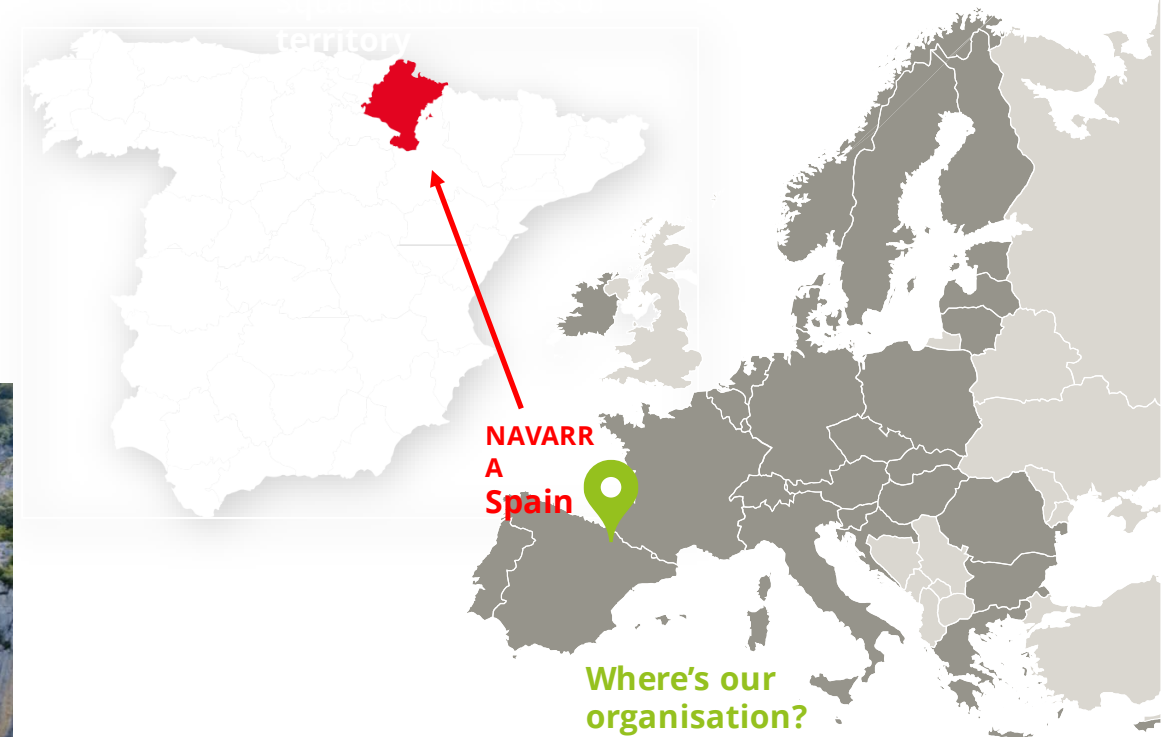

Our experience

1. Environmental clauses in the contract for Pamplona street cleaning services

Pamplona Town Hall

Environmental clauses, including **life cycle analysis (LCA) and carbon footprint (CF)**, considered in the launch of tender for Pamplona streets cleaning service.

- ISO 14064, ISO 14040, and an internal methodology based on the GRI indicators is used

Evidence of success: Improvement measures resulting in a more efficient service, both from an organizational and an environmental point of view



Our experience

2. Healthy and sustainable menus in municipal nursery schools

Autonomous Organisation of Municipal Nursery Schools of Pamplona

Sustainable award criteria:

- **Products of differentiated quality:** Organic, Protected Denomination of Origin, Protected Geographical Indication, autochthonous breeds, traditional varieties, artisanal production and sustainable fishing or aquaculture
- **Distribution and proximity channel:** non or one intermediary and place of production, slaughter and transformation up to 200 km to the hiring center
- **Kind and format of packaging:** exclusive and reusable or not reusable, but recyclable, compostable and ecological; and big formats

Evidence of success:

- ▶ 10 nursery schools with healthier menus - 1,100 menus/day.
- ▶ 100% of fresh food, 90% organic, 80% local, 75% direct channel.
- ▶ EUR 171,600 return value to the organic sector (annual).

Slovenia

Use of life cycle methodologies, in particular life cycle costing (LCC)

Decree on Green Public Procurement:

- 20 procurement subject where environmental consideration are mandatory

Policy improvement

1. The action plan

Green Public Procurement Plan of Navarra 2023-2030

Lines of work:

- Training and accompaniment to the personnel of the Public Administration
- Market involvement in promoting GPP
- Integration of the GPP in the existing tools and development of own material
- Communication

2. Key results/outcomes

3 training on GPP:

- 26-28 November 2022, 8-10 March and 22-24 March.
- Evaluation survey 4,7 out of 5

- ▶ Supply of vehicles considering life cycle cost (LCC)
- ▶ Supply of 4 electric vehicles considering battery life
- ▶ 8 tenders considering EU label or ISO 14024
