



















### **Description of the practice – Shared Space**







#### Portuguese Road Code (Revision in 2019)

**Shared Spaces Rules (Article 78)** 



- Vulnerable users, namely pedestrians and users of soft modes, can use the entire road lane without restrictions;
- Drivers must not compromise the safety or comfort of other road users, and must stop if necessary;
- Speed limit is restricted to 20 km/h;
- Pedestrians must refrain from behaviors that unnecessarily prevent or hinder traffic flow;
- Parking is prohibited, except in spots where it is authorized.




#### **Creation process – Shared Spaces**



Engagement with local traders through an evaluation survey.

Territorial evaluation accordingly to urban guidelines. Involvement of stakeholders and interested parties. Outlining of proposal.





- Implementation of traffic signs
   (sidewalk and road lane should be at the same level) and drafting of road restriction notice
- Development of communication campaign to raise awareness and foster receptiveness towards the measure.

# Monitoring & follow-up

Traffic counting, post-implementation survey, environment analysis, communication campaign, assessment of transferability of action to other areas, reinforcement of local police to ensure compliance with rules.



## **Evidence of success – Shared Spaces**

Benefit Summary - Rating from 3 (very beneficial) to 0 (no impact)

Objective	Rating	Description
Traffic Reduction	2	Can reduce per capita vehicle travel
Improve road safety	1,5	Reduces traffic volume and speed
Environmental protection and transport choice	2	Encourages use of alternative modes, with emphasis on walking and cycling; Reduces vehicle travel and improves urban environment
Community liveability	3	Encourages community development and involvement with stakeholders
Economic renewal	2	Fosters urban attractiveness and interactions with local traders
