## Scope of the stakeholders meeting

The purpose of this meeting is to provide a forum for the discussion of the low-carbon economy related issues in the straits of Otranto and Corfu, in the framework of the PASSAGE project, which is co-funded by the Interreg Europe programme (<https://www.interregeurope.eu/passage>).
