- It is based on the proper use of resources, the idea of recycling reuse and the model of industrial co-existence.

Circular Entrepreneurship

A key strategy is to strengthen Circular Entrepreneurship by:

- encouraging industrial co-operation (clusters, innovation parks, incubators)
- supporting the organic economy
- adopting the concepts of "repair", "refurbishment", "reuse", "restoration"

The proposed initiatives/actions, for the next two years, of the Ministry of Economy and Development, are:

- (c) Development of National Standards for the circular economy.
- (d) Integration of circularity criteria into business licensing.

- (g) Run campaigns and actions to raise awareness among producers, consumers and society, with various actions (Circular Economy Award, presentation of good practices at national and international level)
