Satakunta economy structure

The cornerstones of economic life at Satakunta region are

energy production

heavy engineering

offshore

process industry

ports and logistics

diversified food industry

Trending sectors in Satakunta

measured as increment in turnover (years 2010-2017):

- *private social and health care (97% increment)*
- *automation and robotics (60%)*
- *food industry (30%)*
- *business services (25%)*
- *HoReCa (22%)*
- *electronics (22%)*

R&D activities in Satakunta

Relatively low activities

Share of population is 4%

Share of industrial production 6%

Share of RD investments:

companies: 1.5%

in public and university sector 0.7%

HINKU - Calculation of Carbon footprint in municipalities

Hinku brings municipalities, businesses, citizens and experts together to create and carry out solutions to reduce greenhouse gas emissions.

The municipalities in the network are committed to an 80% reduction in greenhouse gas emissions from 2007 levels by 2030.

In Satakunta, 4 municipalities (Pori, Rauma, Eurajoki and Harjavalta) are involved

The Nordic Ecolabel or Nordic swan is the official sustainability ecolabel for products from the Nordic countries. It was introduced by the Nordic Council of Ministers in 1989. The Nordic Swan covers 67 different product groups, from hand soap to furniture to hotels.
