First meeting of EMOBICITY Local Stakeholders Group

Interreg Europe Project

„Increase of energy efficiency by Electric MOBility in the CITY” (EMOBICITY)

Date: 28th of november 2019

Location: Cluj-Napoca, at North-West RDA headquarters

The purpose of this meeting was to present the role of the EMOBICITY Local Stakeholders Group within the project activities and to start the identification process of good practices from the North-West Region in order to be presented within the study visit which will be organized in october 2020 in the North-West Region.

The institutions represented at the first EMOBICITY Local Stakeholders Group have committed to take part in the following project activities:

- attending the biannual meetings organized by North-West RDA for the elaboration of the Regional Action Plan in order to promote the electric mobility within the cities of the North-West Region;
- sending relevant information for this field, participating at discussions and informal communications on topics of common interest;
- identifying good practices from the North-West Region;
- attending at study visits organized by the partner regions;

The meeting started with a table tour, in which each participant presented himself and gave a brief description of the organization they represent, focusing on the aspects that strengthens the theme of the project, namely the promotion of electric mobility in the cities of the North-West Region.

During the meeting, participants proposed several ideas of good practices which can be disseminated within the project, and the best ones will be kept for the study visit which will be organized in october 2020 in Romania, as follows:

- IT solutions (software platform) that ensure the monitoring of a differentiated charging system according to certain criteria, fuel price changes, or the collection and interpretation of the feedback received from the EV's owners;
- creating a low balance application for energy suppliers to optimize the energy price;
- electric busses for the surrounding areas of the cities and electric vehicles for the transport of goods in the vicinity of the cities;
- searching for new spots where to set up fast charging stations for EV's inside the cities of the North-West Region;



- identifying and settling incompatibilities between the manufactures of charging stations and the energy suppliers;
- pinpointing the storage and recycling options for EV's batteries (since these batteries are seen as dangerous waste);

Taking into consideration that one of the project activities involves identifying good practices from the partner regions, each representative was asked to submit proposals in this regard. Once with the study visit that will be organized in Romania during october 2020, some of these initiatives will be selected and analyzed in more detail in order to schedule visits at the locations of these initiatives. The visits will be attended by representatives of partner regions in the project.
