2nd meeting of the Stakeholders Group (SG) for EMOBICITY

Interreg Europe Project

“Increase of energy efficiency by Electric MOBility in the CITY”

Date: 23rd July 2020

Location: online via ZOOM

The purpose of this meeting was to present the events that took place within the Emobicity project in the 2nd semester (February – July 2020).

In the opening part of the online meeting, Mrs. Cristina David, project manager, presented the stage of project implementation at the end of the 2nd semester. She also mentioned that the five good practices identified with the help of SG members, were listed and accepted as good practices and were posted on the Interreg Europe platform.

The good practices identified within the North-West Region are as follows:

- 1. Replacing the entire public transport fleet in Turda with 20 electric buses**
- 2. Ecological events in Bistrita - excellent opportunities to promote the electric bicycles (Database)**
- 3. Infrastructure stations for recharging motor vehicles available in municipalities (Database)**
- 4. Replacing urban public transport fleet in Cluj-Napoca City**
- 5. RABLA PLUS – Funding Program promoting energy-efficient road transport vehicles (Database),** and they can be seen by accesing the following link:

We mention that the good practices from positions 2, 3 and 5 were included in the database of the Interreg Europe program, where the most representative practices identified in the projects implemented within the Interreg Europe program are posted, which excel in originality, approach and the implementation of the identified good practices.

Next, the activities that will take place in the 3rd semester were presented, with a focus on the acquisition of external expertise services for the elaboration of the Regional Action Plan (RAP), the main deliverable of the project, and the study visit which will have to be organized in Romania during October or November 2020. Probably the event will be organized online (due to COVID-19 pandemic) with the support of SG members.


In the second part of the meeting, Mr. Paul Pantis, implementation expert within the project, presented to SG members a summary of the discussions held throughout the Workshop organized by the Croatian partners during the second day of the study visit, organized online, on the topic of “Improvement of



Charging/Taxation Models - Energy price for charging". In this context, Mr. Marius Tudor, General Secretary of the Automotive Manufacturers and Importers Association from Romania, was the one who had a very interesting presentation at this event.

Mr. Marius Tudor also added at today's SG meeting, that currently there are available 53 million euros from the European Union through a call for projects launched by the Environment Fund Administration, for the development of the charging and/or fast charging infrastructure along the national roads and highways, the grant part being 90% of the total value of the project, funds that can be easily accessed by the public local authorities with a 10% co-financing rate. These funds are meant to increase the total number of charging and/or fast charging stations along the main national roads or highway, in order to increase the number of EV owners that travel on longer distances using ecofriendly means of transport.

At the end of the SG meeting, the members expressed their interest in receiving the presentations from the Workshop organized by EIHP Croatia on 2nd of July 2020. The presentations were sent to the SG members via email.
