Third meeting of the Regional Committee of Representatives EMOBICITY

Interreg Europe Project

“Increase of energy efficiency by Electric Mobility in the CITY”

Date: December 16, 2020

Location: online via ZOOM

The purpose of this meeting was to present the events that took place so far, within the Emobicity project, close to the end of the third semester (August 2020 – January 2021), as well as the activities which will be implemented in the next period of time.

In opening the online meeting, Mrs. Cristina David, project manager, presented the stage of project implementation, mentioning the workshop organised by North-West RDA on 05.11.2020 on the theme “National/regional/local policies for promoting electrical mobility in partner regions” and the stage of the procurement of external expertise services for the elaboration of the Regional Action Plan (RAP), the main deliverable of the project. The Regional Action Plan (RAP) will be drawn up starting with the 4th semester, as soon as the contract with the company that will produce this document is signed.

There were presented the activities to be carried out at the end of the third semester and starting in the fourth semester, namely the completion of the procurement of external expertise services for the development of the Regional Action Plan (RAP) and the organisation of the next study visit to the Azores Islands (Portugal).

In the second part of the meeting, Mr. Paul Pantiș, project implementation expert, presented to CRR members a summary of the presentations and discussions held at the workshop organised by the North-West RDA in 05.11.2020, via online, on the theme “National/regional/local policies for promoting electric mobility in partner regions”.

He presented the results of the implementation of projects funded through ROP 2014-2020 Axis 4, PI 4.1 Promoting carbon reduction strategies for all types of territories, in particular urban areas, including the promotion of sustainable urban mobility plans, and the policies to improve the electricity mobility identified at North-West level. Finally, he called for the support of the stakeholder group members to collect proposals to improve and simplify the application submission process, as well as opinions on the structure and consistency of the applicant’s guide.

Attached to the documents that will be submitted to the stakeholder group members will also be a feedback form, regarding the problems/difficulties encountered by the beneficiaries during the implementation of the projects submitted on axis 4 PI 4.1 of POR 2014-2020, as well as the measures to improve and/or simplify the submission process of the financing applications in the next programming period. The purpose of this approach is to provide support to North-West RDA, as MA (Managing Authority), for the next ROP



