# **CE IN ROMANIA - Legislation**

- The European Legislation in the field of waste has been transposed into national legislation as follows:
- 2002 Government Decision no. 856 on the records of the waste management and approval of the list containing the waste
- 2010 Law no. 132 regarding the selective collection of waste in public institutions
- 2011 Law no. 211 on the waste regime, republished 2014 amended by the Emergency Ordinance no. 68/2016
- 2015 Law no. 249 regarding the management of packaging and packaging waste
- 2018 Emergency Ordinance no. 74/ for amending and supplementing Law no. 211/2011 regarding the waste regime, of Law no. 249/2015 regarding the management of packaging and packaging waste and the Emergency Ordinance no. 196/2005 regarding the environmental fund.



## **CE IN ROMANIA - Legislation**

- The legislative package has been elaborated with the purpose of aligning the Romanian and European legislation in the field of waste management, and aims to implement the economic instruments "pay as you throw", "extended producer responsibility" and "storage tax", as well as the establishment responsibilities of all parties involved, including taking into account the changes made by promoting the circular economy package.
- In line with the approach at the European Commission level, which is reflected in the circular economy package, the "contribution to the circular economy" is set instead of the deposit tax.



# **CE IN ROMANIA - Legislation**

- Although the Waste Framework Directive was transposed in 2011 by Law no. 211, the achievement of the objectives remains a challenge for Romania:
- minimum 50%, preparation for reuse and recycling of paper, metal, plastic and glass waste (coming from households and possibly from other waste streams similar to household waste), by 2020;
- 70% preparation for re-use, recycling and other material recovery operations for non-hazardous waste from construction and demolition activities, by 2020 at least.





# **CE IN ROMANIA** policy framework

# Institutional actors responsible for resource efficiency policies:

- Ministry of Economy, Energy and Business Environment Is dealing with:
  - competitiveness and investment policy; innovation;
  - mineral resources, energy efficiency and renewable energy policy.
- ✓ Ministry of Environment, Water and Forests
  - is dealing with waste management policy;
- County Councils & Municipalities
  - management of the waste generated on their territory,
     local taxes...



#### **CE IN ROMANIA**

The early warning report for Romania issued by the Commission on 24.9.2018 on the implementation of EU waste legislation, including the early warning report for Member States at risk of missing the 2020 preparation for re-use/recycling target on municipal waste states that in 2016, Romania's recycling rate (including composting) reported to Eurostat was 13 %, while its landfilling rate was 69 %, one of the highest in Europe.

Based on an analysis of existing and firmly planned policies in the area of waste management, Romania is considered at risk of missing the 2020 target of 50 % preparation for re-use/recycling of municipal waste together with other 13 countries (Bulgaria, Croatia, Cyprus, Estonia, Finland, Greece, Hungary, Latvia, Malta, Poland, Portugal, Slovakia and Spain).

#### **CE IN ROMANIA**



#### **Key findings of this report**:

- Romania's separate collection service, including for biowaste, is not being sufficiently implemented;
- there are not enough economic incentives to move away from disposal;
- extended producer responsibility schemes for packaging are not efficient and do not fully cover the costs of separate collection;
- the necessary infrastructure is still lacking;
- more investment is needed in projects higher up the waste hierarchy (e.g. recycling) that go beyond treatment of residual waste; and
- public engagement in separate collection is very low.



## **CE** in Romania – best practice

#### **SIGUREC**



A broad initiative, implemented in Romania following an official agreement between private companies (Green Group holding, the Large Retailers' Association of Romania - AMRCR, Ecopaper SA, Romcarbon SA, ALRO Slatina) and public authorities – the Ministry of the Environment and Climate Change, municipalities, and recyclers.

#### **CE PROJECTS IN NW REGION**



- 2. <u>C-Voucher</u> Circular value chains within Regional Strategies for European Innovation
  - <u>Partnership</u>: international consortium of development agencies, accelerators, clusters and universities from 6 European states
  - Program: Horizon 2020
  - <u>Budget</u>: 5.21 million euros, of which 1.4 million direct grants for companies (in the form of innovation vouchers) and 2.8 million allocated to the Acceleration Program (coaching support services for the development of innovative solutions)

#### **ACTIONS**:



- 2 financing calls for innovation vouchers in the circular economy (autumn 2018 and autumn 2019)
- 2 financing calls for companies wishing to adopt the solutions developed within the Acceleration Program



#### **CE IN MARAMURES**



Maramures County Council is currently implementing the project "Integrated waste management system in Maramures county", project co-financed from the FEDR through Sectorial Operational Program Environment 2007-2013, with the following results:

- Center for Integrated Waste Management, including the Ecological Warehouse, Sorting Station, Mechanical-biological treatment station and attached buildings and facilities
- Transfer Stations, Sorting Stations & Bulk Waste Collection Centers
- Closing of 6 non-compliant urban warehouses;

 Provision of the necessary equipment and goods (machines, equipment, containers for collection and individual composting).












#### **CE IN MARAMURES**

The Association of Inter-Community Development for the Integrated Management of the Household Waste in the county of Maramureş (ADIGIDM) is formed by the 76 territorial administrative units (cities and municipalities) of the county of Maramureş and the County Council of Maramureş.



The County was divided into 4 areas served by the main center and 3 transfer stations.
