The plan was initially approved in July and work is now focused on adapting it to the feedback received during the public exposure period.</li> <li>1.2 Construction of a traditional fishing boat for educational purposes as a mean to preserve traditional know-how and shipbuilder skills. The construction has been completed and the boat is temporarily on loan to the Club Nàutic Cala Gamba to organise rowing training courses.</li> <li>1.3 Guided visits in the surroundings of the Lighthouse Route to disseminate the cultural heritage linked to the fishing communities. Different guided visits have been made and the stakeholder CNP Cala Gamba is working on the organization of future regular visits.</li> </ul> </li> </ul>

- Action 2 "Enhancing local fishing community as an economic resource":
- 2.1 Installation of signposting to indicate, inform and warn hikers along the route to facilitate orientation. The itinerary is already signposted.
- 2.2 Promotion and dissemination of the hiking route through the Official website of hiking routes and the official APP for mobile devices: "Hiking in Mallorca". The itinerary is already available in the official APP. The Department is designing more promotion and dissemination material.
- 2.3 Involvement of the Maritime Museum of Mallorca.
- The participants were informed of the Final conference of the project in Middelburg (8th November 2022).
- The participants were informed of future projects related to maritime heritage:
- Consell de Mallorca has been involved as partner in a project proposal submitted to the last Interreg Euro-MED call. If the project is approved, we will be able to share experiences on hiking routes as cultural products, including routes linked to the CHERISH action plan.





-	Consell de Mallorca will submit a project proposal to Europe Creative call (Culture – cooperation projects). This proposal is focused on the preservation and promotion of traditional maritime skills in the digital age (traditional shipbuilding and sailing). In the framework of Erasmus+ programme, Consell de Mallorca will host a French delegation to share experiences and actions related to the maritime heritage.
•	After the meeting, participants attended the launching event of the boat built in the framework of the Action Plan (action 1). The media were invited to the event.
