POLICY CHANGE: Background

- EkoSMART eCare practice from Slovenia: raise interest in Cyprus
- New project based on EkoSMART ("Smart Integrated Healthcare and Long-term Care System" (eCare)
- New innovative service established in the sector of Home Health Care in Cyprus to be funded in the framework of the selected policy instrument (reserved funds – Structural Funds of Cyprus)



POLICY CHANGE: Actions Proposed in AP

- Project 'fiche' submitted for approval by the e-Government Committee of Cyprus
- Technical document submitted to the MA for financing the project through ERDF OP (oral confirmation already granted in the presence of the President of Cyprus)
- Study visit in Slovenia to analyze in detail the technical specificities of the GP and adapt in local environment accordingly
- Project Implementation



POLICY CHANGE: Players involved

- Directorate General for European Programs, Coordination and Development (DG-EPCD) Managing Authority of the Policy Instrument
- Ministry of Health Final Beneficiary of the new project

- Nicosia Development Agency (ANEL) - provision of support on management and coordination level of the new project to the Final Beneficiary

Through the active participation of the partner in the process, monitoring and reporting will be smoothly achieved.

Two years project implementation from April 2018 until March 2020 corresponding to HoCare phase 2
