- Q: How to motivate partners from the consortium to be a coordinator? Thank you!

 A (Interreg Europe): Every consortium needs one lead partner. Even if the LP bears responsibility, this is also shared in the consortium and the JS supports all LPs
- Q: What do the member of the stakeholder group have to do in the project?

 A (Interreg Europe): Good morning! Well first they contribute and enrich the learning process. Remember that this is multidimensional process meaning the learning must go beyond the individual, to partners and stakeholders. At the same time they support the policymakers at regional level and they contribute to the exchange of experiences at interregional level.
- Q: What kind of policy advice can I get from the policy learning platform?

 A (Interreg Europe): The policy learning platforms provide different services, e.g. policy helpdesk where you can seek advice for a specific challenge or demand-driven peer reviews
- Q: Is there any limit for the number of expert partners in a consortium? The wp mentions a recommendation for max 1.
 - A (Interreg Europe): Our recommendation is indeed 1 as indicated in the programme manual.
- Q: Good morning. Thank you for your presentation. I would like to know which is the most represented investment priority during the past two calls for proposals?
 - A (Interreg Europe): Hi Victor! It is first one, Strengthening Research, technological development and innovation (corresponding to Thematic objective &)
- Q: The picture of underrepresented regions was not too clear, is it possible to share the list with us?
 - A (Interreg Europe): Please find the list of NUTS2 regions not yet represented in the programme in the terms of reference:

- Q: Are there any guidelines for dividing the budget? e.g. academic vs. stakeholders or across countries?
 - A (Interreg Europe): It is most important to keep in mind that the activities and therefore the type of involvement are the basis for building the projects budget.
- Q: What's the best way to make a non-profit organisation participate in a project?

 A (Interreg Europe): If a policy change/improvement is important and relevant for an organisation (non-profit organisation or public body), they will be motivated to participate.
- Q: Can a development agency in-house company of a Region be the Lead Partner?

 A (Interreg Europe): If the partner fulfils the eligibility criteria to participate and the policy relevance of the partner is given, there are no reasons why a development agency in-house company could not be a lead partner.
- Q: Can the budget of the programme fund the meetings with the partners?

 A (Interreg Europe): Indeed, partners should include in their budget costs for the organisation of the project's meetings.

Q: Is there an unofficial limit for partners?

A (Interreg Europe): There are no unofficial things, everything you need to know is in the programme manual:

http://www.interregeurope.eu/fileadmin/user_upload/documents/Call_related_documents/Interreg_Europe_Programme_manual.pdf As the manual reads, a partnership between 5 and 10 appears to be the best configuration.

Q: Which is the profile of the leading partners in Interreg Europe? Are they for example often regional authorities?

A (Interreg Europe): Mainly public authorities with the capacity to influence the policy instruments addressed. We also have other types of lead partners in Interreg Europe. Swiss partners and non-profit organisations cannot become lead partners.

Q: It can be funded by an intervention research as a pilot project?

A (Interreg Europe): There is no need to think about pilot actions at this stage of the application.

Q: Does the presence of regional and local authorities/organisations in the same project make the consortium not well built?

A (Interreg Europe): No. The consortium can be a mix of regional and local authorities. What matters is the authority's relevance with regard to the policy instrument to improve.

Q: How the development of a site can be funded? In which phase?

A (Interreg Europe): The projects' websites are hosted by the programme hence you do not need to plan costs for the development of a website

Q: How can we demonstrate the improvement in our regional policies / OPs?

A (Interreg Europe): Please refer to the programme manual, section 4.3.1. to read more about different ways how policies can be improved. Report on results in the progress report.

Q: Can universities be lead partners?

A (Interreg Europe): Yes they can. But not in all countries... depends on the status of universities in your country. University can be LP as long as it is governed by public law. University can come either as regional (lead) partner or as advisory (lead) partner

Q: Where can we find a list with the percentage of applications for every topic?

A (Interreg Europe): Please have a look at the section dedicated to facts and figures on our website, http://www.interregeurope.eu/about-us/facts-and-figures/

Q: What happens if I have already found, outside the Interreg Europe frame, the ideal partner? Can I involve him to join and how?

A (Interreg Europe): Also, partners from outside the programme area, hence not from one of the 28 member states + Norway and Switzerland, can join. However, those partners have to participate on their own costs, they cannot receive funds from the programme. Important to highlight the added value of the partner for policy improvements in the programme area.

Q: Are the proposals that involve the most Managing Authorities given priority in terms of winning? Usually it is extremely difficult to convince the MA.

A (Interreg Europe): No. What matters is 1) the partner's relevance in connection to the policy instrument (SF or not) and 2) at least half of the policy instrument tackled

in project by EU partners need to be Structural Funds programmes (ideally with MA, if not: letter of support)

Q: What is a policy instrument?

A (Interreg Europe): It is a means of public intervention, it refers to any policy or law developed by public authorities and applied to improve a specific territorial situation. Please see section 4 .1 of the programme manual

Q: What is the dead line for submission of the proposal?

A (Interreg Europe): 30 June 2017, 12:00 noon CEST (Paris time)

Q: Is Interreg Europe a co-financed call type? For example, policymakers are co-financed or completely financed?

A (Interreg Europe): Yes we are co-financing the projects. Depending on the legal status of the partner, they are co-financed at 85% (public) or 75% (private non profit).

- Q: Can be more than one partner form the same country be in the partnership?

 A (Interreg Europe): Yes they can. There can be 1) several partner from the same region or 2) several partners from the same country representing different regions. if well justified. In any case, the budget should be allocated wisely.
- Q: Do changes in the policy instrument need to happen in the lifetime of the project?

 A (Interreg Europe): Results can happen at every moment. We expect them during phase 2, i.e. during the first two years of implementation of the action plans. Further changes may occur after the end of the project.
- Q: Are private profit partners co-financed as well?

A (Interreg Europe): No, only private non-profit organisations.

Q: Is there a maximum / minimum number of countries / regions represented in a partnership?

A (Interreg Europe): We recommend to have between 5-10 partners. There need to be at least 3 partners from different countries (at least 2 EU countries).

Q: What's the role of the managing authorities (MA) within the project and the partnership? A (Interreg Europe): Ideally, the MA is project partner, i.e. participates actively in all project activities and receives funding from the programme. In case the MA cannot be partner, it can still be involved through the stakeholder group.

Q: 1 region - 1 policy. 1 Province (LP) and 1 Region (partner) will address 1 same policy and no letter of support is required by the Province?

A (Interreg Europe): If the policy responsible body for the policy instrument is a partner, no letter of support is needed.

Q: We would like to know if the program funds the development of a website to deliver results of the project and to be the information mediator between parts_

A: If this is a tool for exchanging experience and the relevance is demonstrated for the project implementation then it can be financed in phase 1

A: If you are referring to pilot actions then we will see in due time

Q (Agnes): I am wondering how to define the policy instrument - is it better to make it bigger (a measure) or smaller (sub-measure) What are advantages and disadvantages?

A: The more specific the better!

Q (Agnes): Are there any consequences when we enlist a stakeholder in the application and when it comes to realisation - he doesn't want to be a stakeholder anymore?

A: No it is a dynamic process, stakeholders involved can change during the course of the project (and in the application form the list is just indicative)

Q (Agnes): Where can I find indicators: are the specific obligatory? what self-defined performance indicator need to refer to?

A: There is some pre-defined indicators which you have to use. In addition, self-defined performance indicators have to be defined for each policy instrument.

A: For the self-defined performance indicators, it is up to you to define them. They can also be changes later on.

Q (Agnes): I plan to show a measure and two sub-measures that this measure consist of. Then I need to have one Plan of Action for measure or two for the sub-measures?

A: it will be considered as only one policy instrument, meaning you just need to have one action plan
