Cohesion Policy in the European Green Deal



"Cohesion Funds play a crucial role in supporting our regions and rural areas from East to West, from South to North to keep up with the transformations of our world.

*In this transition, **we must recognise and respect that we do not all start from the same point.** We all share the same ambition but some may need more tailored support than others to get there."*

-  Investing in place-based innovation and smart economic transformation
-  Deploying technological and social innovation on a large scale
-  Facilitating phase-out of unsustainable practices
-  Ensuring a just transition for all regions

Policy Objective 2: A Greener Europe



- Eight specific objectives for ERDF and CF:
 - i. promoting **energy efficiency** and reducing greenhouse gas emissions;
 - ii. promoting **renewable energy** in accordance with Renewable Energy Directive (EU) 2018/2001, including the sustainability criteria set out therein;
 - iii. developing **smart energy systems, grids and storage** outside TEN-E;
 - iv. promoting **climate change adaptation**, and disaster risk prevention, resilience, taking into account eco-system based approaches;
 - v. promoting access to water and **sustainable water management**;
 - vi. promoting the transition to a **circular and resource efficient economy**;
 - vii. enhancing protection and preservation of **nature, biodiversity** and green infrastructure, including in urban areas, and **reducing all forms of pollution**;
 - viii. promoting **sustainable multimodal urban mobility**, as part of transition to a net zero carbon economy;

Energy efficiency measures (SO 2.1)

- This includes, for instance:
 - Energy efficient renovation of public buildings
 - Energy efficient renovation of residential buildings
 - Energy efficiency in SMEs
 - Energy efficiency improvements of district heating networks
- Contributes to:
 - Renovation Wave, 2030 climate targets, 2050 climate-neutrality (European Climate Law)...

Renewable energy (SO 2.2)

- This includes, for instance:
 - Renewable energy in heating and cooling
 - Small-scale electricity generation based on renewable energy
 - Renewable energy technologies that are close to market or not yet widely deployed
- Contributes to:
 - EU Hydrogen Strategy, 2030 climate targets, 2050 climate-neutrality...

Smart energy systems, grids and storage at local level (SO 2.3)

- This includes, for instance:
 - Smart energy systems at local level, including smart electricity distribution grids, related demand-side measures, and storage solutions
- Contributes to:
 - EU Energy System Integration Strategy, 2030 climate targets, 2050 climate-neutrality...

CC adaptation, risk prevention and disaster resilience (so 2.4)

- This includes, for instance::
 - Prevention measures (e.g. improving knowledge base, awareness-raising, flood protection infrastructure...)
 - Preparedness measures (e.g. early warning systems, equipment, training...)
- Contributes to:
 - RescEU, Adaptation Strategy, European Climate Pact...

Sustainable water management (SO 2.5)

- This includes, for instance:
 - Wastewater collection and treatment
 - Drinking water supply and improving drinking water access
 - Stormwater management
 - Improve water networks
 - Improve monitoring and capacity-building
- Contributes to:
 - Zero Pollution Action Plan, Adaptation Strategy...

Transition to a circular economy (SO 2.6)

- This includes, for instance:
 - Awareness-raising, sustainable consumption
 - Improve the knowledge base and capacity-building for all stakeholders
 - Support for upper stages of the waste hierarchy, incl. waste prevention, reuse, repair, separate collection....
 - Modernise or upgrade existing recycling and waste treatment infrastructure
 - Introduce smart technologies to improve resource efficiency, waste collection
- Contributes to:
 - Circular Economy Action Plan, European Industrial Strategy, Textiles Strategy...

Biodiversity, green infrastructure, reducing pollution (so 2.7)

- This includes, for instance:
 - Biodiversity protection, ecosystem restoration
 - Green infrastructure
 - Measures to improve air quality (incl. monitoring)
 - Decontamination and rehabilitation of industrial sites, contaminated land
 - Noise reduction
- Contributes to:
 - EU Biodiversity Strategy, Zero Pollution Action Plan, Soil Strategy, EU Forest Strategy, European Climate Pact...

Excluded from support

- decommissioning/construction of nuclear power stations;
- investments to reduce GHG emissions from **ETS activities**;
- tobacco and tobacco products;
- undertakings in difficulty (unless authorised by temporary state aid rules);
- airport infrastructure*;
- disposal of waste in **landfill***;
- increasing the capacity of facilities for the **treatment of residual waste***, except;
 - technologies to recover materials from residual waste for circular economy purposes;
- production, processing, transport, distribution, storage or combustion of **fossil fuels**, except:
 - replacement of solid fossil fuels fired heating systems with gas-fired heating systems[†];
 - certain investments in existing gas infrastructure[†];
 - clean vehicles for public use, and vehicles/aircraft/vessels for civil protection.

* with certain exceptions

[†]under certain conditions

note: different exclusions apply for JTF

Higher ambitions for long-term transitions

This is what we need our programmes to do better:

- Develop a **vision** of a sustainable future, and formulate **pathways**
- Put in place a system of proactive **governance** to manage the transition
- Support **innovation** to develop sustainable solutions
- Support **deployment** of innovation, and **phase-out** of unsustainable practices
- Ensure a **just transition** so that the transformation benefits everyone
- Apply specific **territorial approaches** to the delivery of the Green Deal (e.g. cities, rural areas, coal regions)
- **Mainstream sustainability** into programmes and projects

European Territorial Cooperation (ETC)

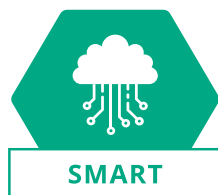
Interreg: 4 strands, ~100 programmes, over 8 billions EUR ERDF

Sharing solutions for better regional policy



Interreg Europe **rationale**

Supports the identification and transfer of good practices among EU regions in order to **improve regional development policies**

Helps policy makers to find new solutions to their challenges

- Primarily dedicated to **public authorities**
- Focus on **exchange of experience**



Different from cross-border or transnational cooperation

Two actions



Projects

Limited number of regions exchanging and transferring experience on a shared regional development issue



Policy Learning Platform

Further exploiting projects' achievements and opening up the programme benefits to all

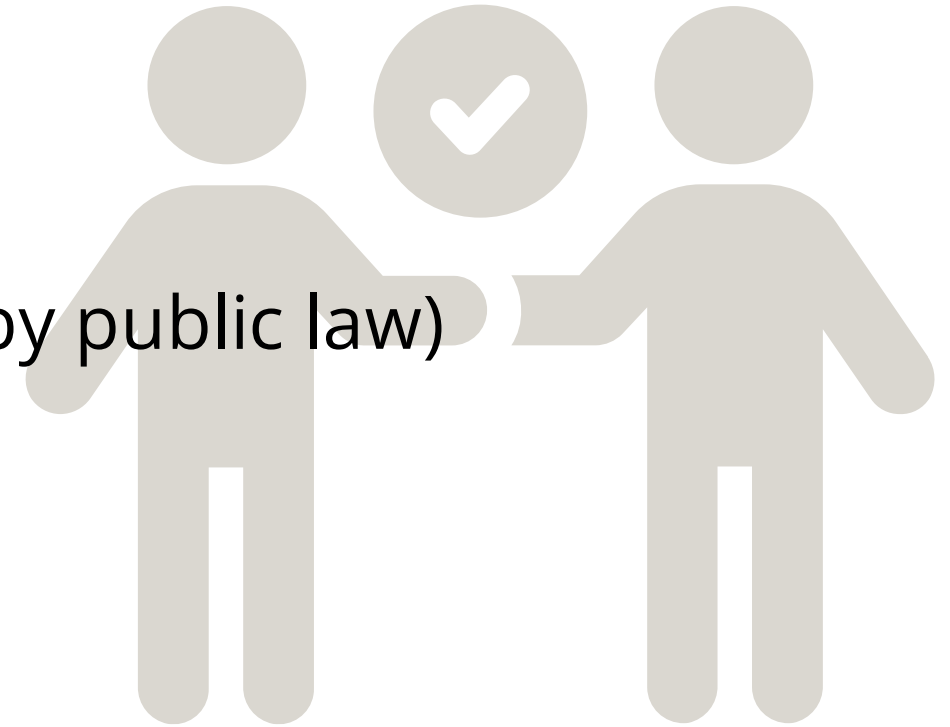
Projects' main features



- **Objective:** Improve the **policy instruments** of the participating regions
- **Activities:** exchange of experience & **capacity building** through identification and transfer of good practices
- **Duration:** 2 phases in **4-year** implementation

Who is **eligible**?

- **Public authorities**
- **Public law bodies** (bodies governed by public law)
- **Private non-profit bodies**



Policy relevance of partnership

Policy responsible authorities must be involved in the project:

- As **partners** for at least **50%** of the policy instruments addressed
- As '**associated policy authorities**' for the remaining policy instruments

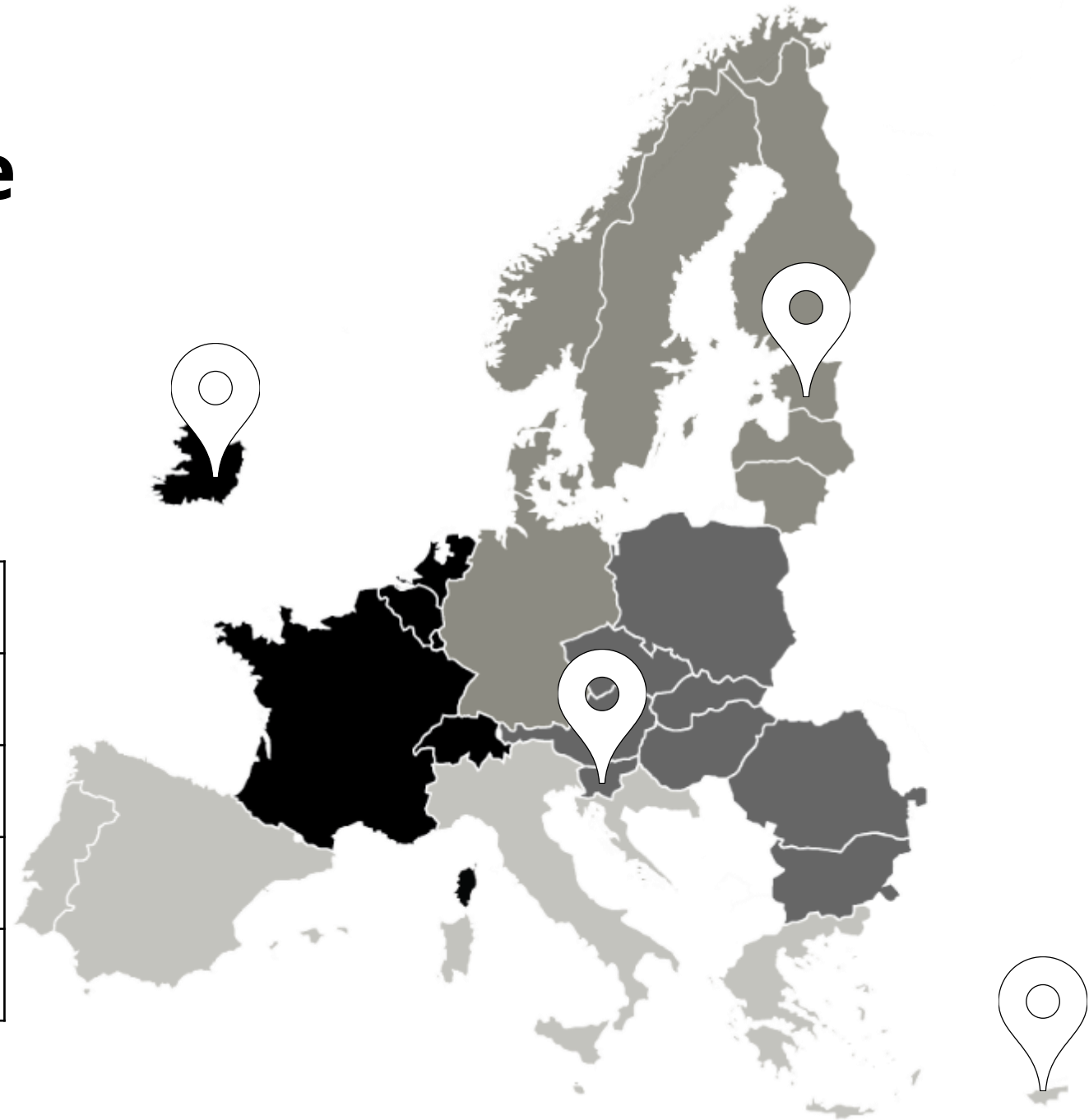
Creation of a **stakeholder group** in each region



Geographical **coverage**

- **Four areas** to be covered
- Mix of more and less advanced regions

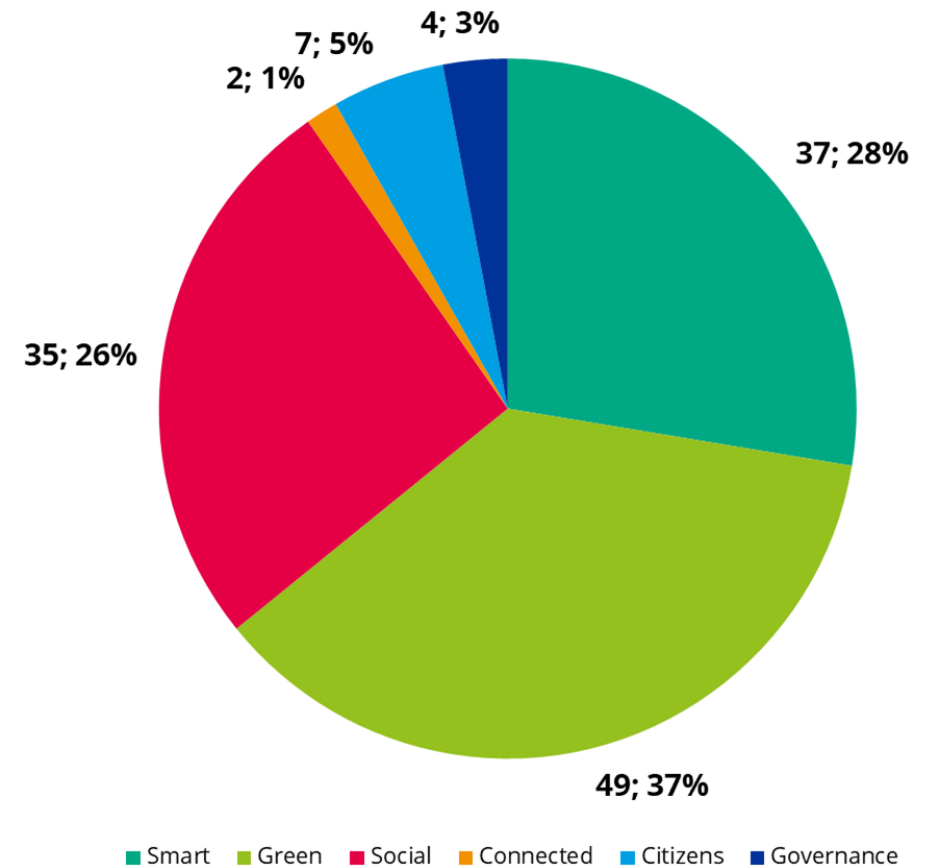
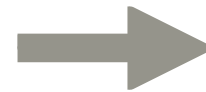

First call **key figures**

Closed on 31 May 2022

First call - **first lessons learned**

- Ensure that partnership goes **beyond transnational** cooperation areas (e.g., MED covers Slovenia, Bulgaria and part of France)
- Check carefully the **'policy responsible authority' status** of the organisation involved in the project
- Select carefully the **policy instrument addressed** in each region
- Ensure that at least **one** instrument is an **Investment for growth & jobs goal programme**

Decision: **end of 2023**

Application pack available in **early 2023**

Key to **successful project preparation**

- Thorough **preparation**
 - Read programme documents carefully (e.g. the manual)
- **Assistance** tools
 - Use self-assessment tool
 - Ask for JS feedback (during open call)
 - Join assistance events
- Get to know our **selection process**
 1. Eligibility = ineligible proposals get **no further assessment**
 2. Quality criteria = meet programme expectations




