



Sustainability Jam Session. TLJ1 Navarra. **QUESTIONNAIRE OF PUBLIC POLICIES IN NAVARRA**

- There are numerous public policies in place with acceptable scores (average of 3,8 over 5)
- **High level of effectiveness and urgency**: policies address problems of interest, which implementation should be carried out immediately, and they have the potential to effectively achieve the challenges they aim to solve
- **Moderate level of viability**: there are difficulties for implementation of those policies and there is room for improvement

Sustainability Jam Session. TLJ1 Navarra. **POINTS TO HIGHLIGHT**

- Public policies are recognised as effective and urgent, which acknowledges the importance of addressing the challenge of valorising inert and inorganic waste.
- However, the assessment of their viability suggests that there are obstacles in their implementation.
- There is not one focal barrier to address, but rather multiple significant barriers at the same time.
