
Geostrategic location (Pan-European Corridor IV, 2 national highways A10, A13, proximity to railway lines)




The SUSTAINABLE URBAN MOBILITY PLAN (SUMP), revised in 2022


- Major interventions on the road network solutions to adapt the existing network to improve traffic flow
- **Public transport -** a strategy to improve the quality, safety, integrity and accessibility of public transport services
- Freight transport measures to move routes where freight vehicles are allowed access to peripheral areas
- Alternative means (systems) of mobility a package of measures to increase walking and cycling attractiveness, safety and security
- Traffic management
- High complexity areas complementary to solutions already in place implemented in high complexity areas, public space planning solutions and traffic regulations are proposed
- Intermodal structure and necessary urban planning operations measures proposed in the URDP contribute to a better integration between modes of transport and transport modes available.
- 54 intervention measures/actions

Challenges

- The financial envelope identified for interventions in the field of mobility in the Municipality of Alba Iulia in the period 2021-2030 consists of approximately 68% non-reimbursable external funds.
- The reluctance of citizens towards new solutions that seem to disadvantage them, that make it difficult for them to carry out their daily activities, but that in the medium and long term will lead to an improvement of their environment, to an improvement of their health, to a reduction of the negative impact on society
- The measures and projects selected to achieve the vision of mobility evolution produce optimal effects when they work together as a comprehensive package, touching on different areas that define the urban transport system.
- Delays in the implementation of some proposals can lead to a reduction in the expected effects due to the operation of other interventions, ultimately leading to a reduction in the effects of the overall impacts of the plan.
