Introduction

WEEEWaste aims to implement better national, regional and local policies for management of WEEE, covering the main recommendations of the "Circular Electronics Initiative" from the EU Circular Economy AP.

The final objective of WEEEWaste is to promote reuse, collection, recycling and other forms of recovery of waste electrical and electronic equipment, supporting thus the achievement of the WEEE Directive 2012/19/EU.

Partners from 8 regions (Czechia, Italy, Germany, Spain, Romania, Hungary, Poland and Slovenia) will exchange practices in a discovery journey to modify their policies, focusing on:

- To improve the interregional coordination of municipalities and regions in order to fight more effectively against illegal shipment between areas and WEEE dumping.
- To introduce a holistic approach to the WEEE management, designing and testing practices which introduce the full sustainable consumption approach defined by the EU Circular Economy Action Plan (refuse; rethink; reduce; reuse; repair; refurbish; remanufacture; repurpose; recycle; recover).

2nd Interregional Event Summary

International events related to the WEEWASTE project were held in Campobasso on 17 and 18 October.

In particular, a workshop was held on 17 October in which local actors with expertise in the field of waste management with special reference to e-waste.

The meeting was well attended and the speakers gave excellent presentations that aroused curiosity in all participants.

Day 18 was characterised by the project meeting where all partners discussed the implementation of the reporting platform. The focus was also on financial reporting. In addition, communication issues and the rules to be followed were reiterated.

Very interesting was the guided tour at the municipal waste collection centre. We first saw the dedicated info

point in the city centre and then visited the ecological island and its waste disposal model with a focus on electronic waste.

2nd Project meeting

On October 18, at Gal Molise verso il 2000 premises, technical assistance of the municipality of Campobasso, the second steering Committee of the Weewaste project was held.

The event was held with the participation of the entire partnership and began with a summary of project activities by the Lead Partner. In particular, a focus was made on the management of the Interreg Portal platform as we are in the process of reporting on the activities of the first semester. Guidance was given regarding the compilation of the report from an administrative and financial perspective.

Immediately following this was a supervision and explanation of the market analysis required by the project and which will be released at the end of the first year of the project.

Rounding out the project meeting session was an explanation of the communication activities to be undertaken to disseminate the project results. In particular, special attention was requested to the use of logos and the use of social channels as well as the rules dictated by the program in terms of compliance with the required visual identity









Study Visit

On the 18th October 2023 project partners and stakeholder attended second Study Visit of the WEEEWaste project. Study Visit took place at MUNICIPAL COLLECTION CENTER in Campobasso (SEA Servizi e Ambiente s.p.a.), Molise, Italy. Representatives of the company introduced technologies, selection process of the e-waste and legislative process.

SEA, Servizi ed Ambiente Spa, is a joint-stock company that provides essential public services according to the in-house providing model. That is to say, it is a company which, although endowed with an autonomous legal personality, by its very connotation, is justified as an 'internal office' of the public body that set it up, since the Municipality of Campobasso holds all the share capital, qualifying itself as sole shareholder, and controls it in terms similar to the hierarchical control exercised over its own offices.

SEA's corporate purpose is the production and management of services aimed at the protection, preservation, and enhancement of environmental quality through the management of the integrated waste cycle, urban hygiene and health, the management of green areas, the snow removal service, and the management of car parks.

SEA carries out all its activities in favour of the Municipality of Campobasso.

Since 2005, the company has been certified for Quality and Environment (to date ISO 9001:2015 and ISO 14001:2015) and has adopted the Organisation, Management and Control Model pursuant to Legislative Decree 231/2001.


