Methodology No. 1 on

analysis of partner's situation and diagnosis of good practices

Purpose: This methodology helps to both **perform analysis** of partner's situation and **diagnose good practices** with regard to:

- 1) the regional development problem that is described in the project application by the partner,
- 2) the regional policy (policy instrument) that is indicated in the project application by the partner,
- 3) the expected policy improvement (improvement of policy instrument) as identified in the project application by the partner, which is a selection from the following:
 - a) new projects financed by the instrument,
 - b) change in the management of the instrument,
 - c) revision of the instrument itself

3	Identify effective, less effective, and ineffective policy interventions that address partner's regional development problem.	Explain why some policy interventions are in your view less effective / ineffective: - is it because of the policy intervention is wrong / not suitable / not relevant / badly designed, - is it because of how the policy intervention is implemented, - is it because the existent policy interventions "do not see" the problem, - any other cause (please describe).

2	Identify with which policy improvement type the 'good practice' can be linked (one, two, or all three).	Three policy improvement types: 1) new projects financed by the instrument, 2) change in the management of the instrument, 3) revision of the instrument itself.			
3	Identify to the solution of what (one or all three) regional development aspect the 'good practice' contributes:	E.g., the 'good practice' addresses the regional development problem by enhancing: (a) sustainable growth, (b) SMEs competition, (c) jobs creation within SMEs.			
4	Check the Interreg Europe platform for available 'good practices' that address the regional development problem by enhancing: (a) sustainable growth, (b) SMEs competition, (c) jobs creation within SMEs.
