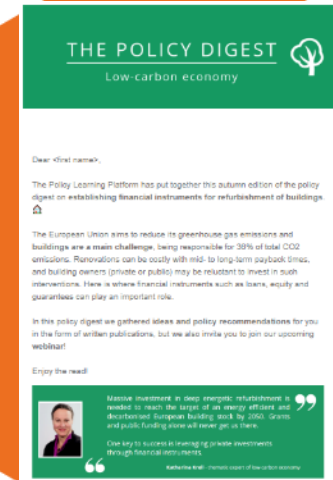

- Online peer review held on **15-16 September 2020**
- **Thematic focus:** Implementation of a circular economy in the Warmińsko-Mazurskie voivodeship
- Final [peer review report](#) endorsed by the Board of the voivodeship on 12 Jan 2021
- Clear **ambitions** for the region's new operational programme (ROP 2021-2027):
 - Including the circular economy in the future regional programme by securing financing of the recommended types of projects for small- and medium-sized enterprises and public institutions under Policy Objectives 1,2 and 4.
- *« Participation in the peer review was an inspiring experience for the region. (...) The adequate examples presented by the peers during the online meetings constitute the basis for activities in the region. They will be reflected especially in the types of support being designed under the regional programme. (...) The circular economy, enriched with the peer review experience, will be its important element. »*
