

Digitalization still doesn't really matter

90%

90% of respondents agree AND or strongly agree that digital technologies are disrupting the industry to a great or moderate extent 93% of those with a digital strategy **agree** or **strongly agree** that the objective of their digital strategy is to **enhance** customer experience and engagement
